The recently ended 2010 fiscal year was such a memorable year for me, and for many associated with Dakota Wesleyan University. As you know, we celebrated and commemorated our 125th anniversary as an institution that has made its mark by transforming the lives of young people.

- We held the Founders' Convocation to kick off our year-long celebration by remembering our past, honoring alumni and dedicating our three colleges: the College of Healthcare, Fitness and Sciences; the College of Arts and Humanities; and the College of Leadership and Public Service.
- We hosted Rwandan genocide survivor Immaculée Ilibagiza, and she told her story of faith and forgiveness to more than 1,000 people on our campus.
- Our faculty, staff and students rallied together on the anniversary of the signing of our charter and performed service activities throughout the Mitchell area.
- "The Dakota Wesleyan University Memory Book, 1885-2010" by James D. McLaird, professor emeritus of history, was released to wonderful reviews from those who lived the stories.
- Our anniversary weekend brought more than 1,000 alumni home to DWU to see one another, celebrate the past and look toward the bright, bright future of the university.
- We surpassed an all-time high annual fund goal of \$690,000. Total giving to all funds exceeded \$2.5 million.
- The John Wesley Society inducted 39 new members for a total of 196. These donors give \$1,000 or more to the Wesleyan Fund which supports annual scholarships and programs.

As I read Jim McLaird's book, I cannot help but marvel at the stories of our students over the past 125 years. Their stories are touching, funny, sad and remarkable. Today's student stories are not that different. In my 10 years as your president, our students have experienced success and achievement, loss and sadness, friendship and love. They have become like family with roommates, classmates and teammates.

The one constant for our students has always been the support of our alumni. The list of names included in this annual report and on our website is from the 2010 fiscal year. But the names represent much more: 125 years of lives that have been changed at Dakota Wesleyan. They represent a commitment to ensure that students will continue to experience a place and an education that is truly transformative, special and unique.
